Engagement and collaboration with the Tribal Nations is a key aspect of project development. OPALCO recognizes that the Tribal Nations with ancestral lands in the San Juan Islands have strong spiritual and cultural ties to salmon and other aquatic species in the region that includes thousands of years of access and use for religious/cultural ceremonies, subsistence, and for commercial purposes. The proposed project would be in the Usual and Accustomed (U&A) fishing area for the region's Tribal Nations who were signatory to the Treaty of Point Elliott, which is a key aspect of why OPALCO started outreach to the Tribal Nations at the inception of the feasibility study.

OPALCO began outreach and hosting meetings with Tribal Nations just over two years ago. OPALCO is continuing engagement through meetings and correspondence at key milestones throughout the duration of the Department of Energy Phase 1 grant process to share information about the potential project and collaborate to assess the feasibility. OPALCO will be working collaboratively with Tribal Nations to identify priority topics requiring study to inform the FERC Draft License Agreement (DLA) application process over the next 9 months. Ultimately, government-to-government consultation with the Tribal Nations will occur between FERC and the Tribal Nations once a DLA application is submitted. The table below includes a detailed log of OPALCO's early and ongoing engagement efforts with Tribal Nations.
