Staff present were General Manager Foster Hildreth; Manager of Engineering and Operations Russell Guerry; Manager of Finance and Member Services Nancy Loomis; Head Accountant Travis Neal; and Executive Assistant Bev Madan (serving as recording secretary). #### **ELECTIONS AND GOVERNANCE COMMITTEE**

The Board appointed Howard Barbour to the EGC to fill Residency District 2 (Orcas) Position B via an email vote on February 17. Four open positions remain.

The EGC interviewed candidates from District 1 and recommended Vince Dauciunas, Mark Madsen and William (Bill) Severson to the slate of candidates. No members filed by petition.

• **Motion** made to request the EGC review Policy 13 and provide analysis and recommendations regarding Board compensation after the EGC District 1 positions are filled. Motion was seconded and carried by voice vote.

#### **VOTING DELEGATES**

NWPPA's annual meeting will be held in Sun River, Oregon May 7-10.

• **Motion** to name Jim Lett the primary delegate and Foster Hildreth the alternate at the NWPPA annual meeting was made and seconded. Motion carried by voice vote.

**Cooperative Response Center (CRC)** will hold its annual membership meeting in conjunction with the NRUCFC Forum June 12 in San Antonio. We do not expect any personnel from OPALCO to attend. The voting will be done via proxy as allowed.

• **Motion** to name Foster Hildreth the primary delegate at the CRC meeting was made and seconded. Motion carried by voice vote.

#### 2016 Year End Financial Review

The unaudited year-end financials were presented for discussion. Highlights included a 1.6% increase in revenue, a decrease of 1.5% in overall expenses, margin of \$3.1M, TIER of 3.24, equity as a percentage of total capitalization 48.7%, and borrowing reduced to \$8.7M due to the early Rock Island Communication loan repayment.

#### **Rock Island Communications 2016 Year End Financial Review**

Adam Kelly SVP of Technology was introduced. The 2016 year-end financials represent the first full year of business for Rock Island Communications. Complete service offerings of fiber, LTE, DSL, IT services and retail operations are in place. Revenue and expenses were consistent with budgetary figures (down only 2.56%); fiber was down 4.62% from budgeted, LTE was up 3.10%, and DSL was up 0.68%.

#### **REPORTS**

- **General Manager** Hildreth highlighted activities with the submarine cable, stating the target date of July 16 is still in effect. Candidate forums are scheduled for the week of March 27 on the four ferry-served islands.
- **Safety Program** There were no loss time accidents in February 2017; total hours without loss time accident is 72,951.

OPALCO's Member Services Policy 16 *Information Requests* Section 2 allows routine information be provided upon request—your request is not for routine information. Further, the policy does not apply to Rock Island.

OPALCO would be at a competitive disadvantage were it to release information contained in private contracts. Policy 16 Section 4 provides limitations on information to be released: Section 4.1 Documents containing matters the knowledge of which would clearly have an adverse effect on the Cooperative's finances; Section 4.2.3. Any other persons' file or record to the extent that such disclosure would violate or would otherwise be an invasion of such person's privacy; Section 4.9 Documents which have been classified by management as confidential.

The purpose of this discussion is to update and provide meeting logistics to the Board for the May 6<sup>th</sup> Annual Meeting.

#### **Election Process**

- The Candidate Forums were successful events on all four islands. Attendance was mediocre (average of 20 members), but members were engaged, asked good questions and the tone was very positive. The San Juan forum is available on video in the Resource Library on the OPALCO website.
- Note that member morale seemed very positive much improved over last year.
   Questions were appropriate to the candidates and members demonstrated a greater
   understanding and appreciation of issues such as rates, broadband and the submarine
   cable project. One member gave a glowing shout-out for the in-depth attention he received
   from staff in response to concerns he had raised at the October Open House Events.
- Election voting opened on 4/13/17 at 10:00 am PDT. Ballot materials went out to all members by email or by USPS, depending on their stated preference. We continue to encourage members to get materials by email and to vote online.

As a follow-up to the December meeting, the Board inquired about company provided mobile phones for Board use. At the time, deployment of the RIC/T-Mobile LTE network had not yet reached a point sufficient for countywide coverage. Since coverage has improved and the completion of deployment is targeted by end of summer, we felt it is time to revisit this subject.

These cell phones will be considered a business tool for the Board members to remain in contact with the organization on a day-to-day basis and during emergency situations. For tax reporting purposes, this is considered a business expense and not compensatory. The purpose of this discussion item is to formalize for the OPALCO record that cell phones will be provided to the Board if they so choose.

#### GENERAL MANAGER'S REPORT April 2017

#### **DASHBOARDS**

Please review the dashboards at <a href="https://www.opalco.com/dashboards/">https://www.opalco.com/dashboards/</a>. Note that all the dashboards are within board strategic parameters. The outage dashboard is still a work-in-progress due to conversion of outage management systems.

#### **ENGINEERING AND OPERATIONS**

#### WIP

As of April 10, there are 395 work orders open totaling \$16,403,692. Six of these projects are associated with the submarine cable project and total \$8,690,100. Operations has completed construction on 55 work orders, totaling \$1,266,604.

#### Safety

The safety training was delayed until April due to an unavailability of Jeff Myers. The meeting was held to review accidents and any safety related matters within the company. The total hours worked without a loss time accident is 81,155.

#### FINANCE AND MEMBER SERVICES

#### **FINANCE**

Preliminary results are showing that March power sales were up by 12.2M kWh, with a net revenue of (power sales minus purchases) of \$952k. From a heating degree day (HDD) perspective, BPA predicted we would experience year-to-date 500 HDDs, when actually we experienced 789 HDDs (March 2016 year-to-date was 452 HDDs). We will continue to monitor and as we approach year end, we may make a recommendation to the Board to credit unbudgeted net margin back to the membership.

#### 2016 Year-End Audit

Staff is currently working with Moss Adams to complete the 2016 year-end consolidated financial statement audit. Moss Adams anticipates that management will be able to confirm the year end results at the Annual Meeting and anticipates that Moss Adams will present the final documents to the Board at the May 18<sup>th</sup> board meeting.

#### **MEMBER SERVICES**

The volume of calls handled by the Member Service team in March was ~2,100+, which was consistent with the same period of the previous year. By the end of March, 237 PAL grants had been awarded so far during the season, totaling \$50.3k, compared to 231 grants, totaling \$39.7k from the same period last year. The Energy Assist Program has grown by another 25 new applications in March, bringing the total program participants to 308 members, who so far this year have received \$19.7k in Energy Assist credits on their bills, and our distributions are below budget.

#### **ENERGY SAVINGS**

The Energy Savings team continued to pay out rebates during March, which included members who took advantage of the new OPALCO rebates related to EV charging stations and ductless heat pumps. The Energy Savings portion of the OPALCO website was enhanced to indicate a

countdown of the remaining budgeted number of ductless heat pump (currently 17) and EV charging station (currently 22) rebates.

#### **COMMUNICATIONS**

#### **Nourdine Jensen Scholarship**

We have 11 applicants for the program, with representation from four high schools and the three major islands. The scholarship selection committee will conduct interviews on April 24-25 and expects to select five scholars for 2017.

#### **FACILITIES**

#### **Eastsound Headquarters**

During the 2017 budget discussion, the capital projects budget for 2017 included a restroom remodel in the Eastsound Headquarters. If you recall, the original cast iron septic pipes had degraded to the point of non-repair. At this point, we need to make the decision to saw cut the concrete slab, replace the septic lines, and rebuild the restrooms or build a new attached restroom addition adjacent to the existing conference room. Staff will obtain estimates for further discussion for the May 18<sup>th</sup> Board meeting.

## It's Like It Never Left: Another El Niño May Be on the Way

Less than a year after one of the strongest El Niños on record, forecasters see an increasing possibility that another will begin later this year.

There is no word yet on how strong a new El Niño might be, but even a mild one could affect weather patterns around the world. Among the potential effects are wetter conditions across the southern United States, including Southern California; a drier Midwest; and drought in parts of Africa, Asia and South America.

An El Niño can also influence global temperatures that are already rising because of greenhouse gas emissions. The strong El Niño of 2015-16 contributed to those years' being the two warmest on record.

An El Niño occurs when warm water in the equatorial Pacific shifts, creating an immense warm zone in the central and eastern Pacific. This adds heat and moisture

to the air, releasing energy that affects the high-altitude winds known as jet streams that circle the planet.

During the 2015-16 event, surface water temperatures in the Pacific were as much as 4 degrees Fahrenheit above normal. The warmth gradually dissipated and the ocean became cooler than normal, a condition known as La Niña, which persisted through much of last year.

In their latest forecast, released Thursday, scientists from the National Oceanic and Atmospheric Administration and other organizations said that conditions were currently neutral, with normal sea-surface temperatures. But there is now about a 50 percent chance of El Niño in the second half of the year, they said.

Mike Halpert, deputy director of NOAA's Climate Prediction Center in College Park, Md., said that since climate scientists have been studying the phenomenon, a swing from El Niño to La Niña and back to El Niño in such a short time — about three years — has happened only once, in the 1960s.

El Niño forecasts are based on computer models of the global climate. Mr. Halpert said those models were somewhat at odds with the conditions forecasters were observing.

"If you just look at the current state of the ocean and the atmosphere, it doesn't really look like what we typically expect to see as we head into El Niño," he said.

"There's been a little bit of head scratching."

The strength of an El Niño is related to the magnitude of the changes in water temperatures. Mr. Halpert said it was too early to say how this new El Niño, if it occurs, would turn out. "But history would tell us we wouldn't see two strong events in three years," he said.

The weather patterns — warmth in the Pacific Northwest is another one — tend to recur in different El Niño years. But there is no guarantee that even a strong El Niño would have a specific result. The 2015-16 El Niño, for example, produced relatively little rain in Southern California.

Still, the generally recurring patterns, coupled with better forecasting, can help governments and other organizations prepare. Dan Osgood, a researcher with the International Research Institute for Climate and Society at Columbia University, said the recent experience of the strong El Niño — which caused droughts in some areas of Africa and excessive rainfall in others — showed the effectiveness of planning.

"One of the really interesting things coming out of the past cycle is that people are more focused on predicting what's going to happen," he said.

The new forecast, he said, should set more planning in motion. "It's about getting organized so you're not caught unprepared," he said.
