All ballots must be received by mail or online no later than 10:00 AM PST on April 10, 2019. Ballots will not be accepted at the annual meeting.

VOTE ONE OF TWO WAYS:

- **1. VOTE ONLINE.** OPALCO offers secure electronic voting in partnership with Survey and Ballot Systems (SBS). This is the preferred method of voting.
- 2. VOTE BY US MAIL. See the enclosed ballot for instructions. Be sure to SIGN THE FRONT OF YOUR REPLY ENVELOPE. Without your signature, your vote will not count.

WHO GETS TO VOTE?

Each *membership* gets one vote, no matter how many meters are attached to the membership, regardless of how many people are named on the membership.

How Many Candidates Can We Vote For?

Each member may select TWO Board candidates for two open positions in District 3 and ONE Board candidate running for one open positions in District 4. Vote in every election regardless of your home district.

WHY VOTE?

OPALCO members are owners of their electric cooperative. You have the power to elect your Co-op Board of Directors who set the rates and make the policies.

How do you Prefer to Receive Your Ballot?

Many of you have already opted out of paper ballots - thank you! For those who are still getting a paper ballot in the mail, there is a place on the ballot to opt out of paper for next year. This is a big cost savings for the Co-op and helps us to limit our carbon impact. A valid email address is essential for voting online. 2019 BOARD OF DIRECTORS ELECTION

The OPALCO governing board consists of seven directors from four districts who are elected for three-year terms, with the elections staggered. Each director is elected by a vote of all OPALCO members, or appointed by the Board to fill out vacancies. ALL members may vote in every election, regardless of their home district.

DISTRICT 3 CANDIDATES PETER GARLOCK



Peter Garlock was appointed to fill a District 3 vacancy in January 2018.

Peter's professional career spans nearly 40 years of experience managing complex technology organizations in both the private and public sectors. He recently retired after serving 15 years as the Director of Information Technology for the Port of Seattle. Under his leadership, a wide range of innovative technology services and systems were developed and implemented to improve operations and serve the traveling public at SeaTac airport and the Port's numerous other lines of business.

BRIAN SILVERSTEIN



Brian worked in the electric utility industry for three decades. He was elected to the OPALCO Board in 2016 and would like to continue serving our community. He and his wife Leslie became full time Lopez residents in 2013.

Brian has a Bachelor of Electrical Engineering degree from The Cooper Union and a Masters in Electric Power from Rensselaer Polytechnic Institute. He worked for 33 years at Bonneville Power Administration, retiring as Senior VP for Transmission with responsibility for planning, operations, engineering, construction, maintenance and rates. One of his key

achievements was connecting over 5,000,000 kilowatts of wind energy to the grid.

He is a NRECA Credentialed Director (National Rural Electric Coop Association).

- Keep electricity affordable for our members by carefully managing the budget and using a small portion of our revenues to assist members who need help paying their bill.

- Be part of the solution in modernizing communications for first responders.
- Transparent decision making.

He has designed and built a home on Crane Island where he enjoys time with his family and community. Peter currently is in his 2nd term on Crane Island Association's Board of Directors. You will often find him on the water paddle boarding through Wasp Passage or trolling a line for salmon anywhere in the islands, just as his mother and grandfather did when his family lived on Orcas during WWII.

Peter currently consults with various companies helping businesses develop strategic and operational planning leveraging his 25-year tenure in mobile/wireless telecommunications, most recently at AT&T. He has led many wireless network acquisitions and partnerships, delivered new network products & services solutions for the customer and is regarded as an excellent builder of teams, organizations and communities.

Jerry is an Aerospace Engineer having worked at Boeing, Rolls Royce Aero Engines, and GE on advanced jet engines. His education includes Bachelors and PhD Degrees from Southampton and Cambridge Universities, UK.

Recognizing early on the need for low carbon sources of energy he invented the first wood pellet stove in 1982 and proceeded to build a successful manufacturing company around this 'carbon neutral' product. He was recognized in 2016 by Seattle Magazine for developing one of the 50 most important products in the Seattle area in the last 50 years.

A distinguished engineering career and a proven entrepreneurial ability provides Jerry with the skills to continue serving the OPALCO membership well.
